



Telephone Triage Quality Review Checklist

Telephone triage, when done effectively, can improve access to the appropriate level of care, practice efficiency, patient satisfaction, and patient/provider communication. Monitor your telephone triage program regularly to assure staff is following practice procedures and that calls are being handled and documented appropriately.

This checklist can be used to evaluate your telephone triage process. Use the results of this review to provide feedback to staff to improve the program.
